



Help After the Storm

n September 1, 2019, Hurricane Dorian, a Category 5 hurricane, tore through the Bahamas, devastating the small islands of Grand Bahama and Abaco. In the wake of this powerful storm, 70,000 people lost their homes, access to food and water was cut, and schools were destroyed.

Within days of the disaster, ADRA was on the ground providing lifesaving food to those in need. Patricia, a resident of Grand Bahama, was one of those individuals. The 70-year-old woman survived the storm, but few of her possessions were saved. Thanks to ADRA, she received homedelivered hot meals that helped sustain her while she sorted her belongings.

"God bless you all, and I love you all," she said. "Thank you very much."

## Building a \$ Better Future

Juana Zelaya is a 57-year-old mother and wife who lives in Las Casitas, a community in the Dry Corridor of Southern Honduras. Las Casitas is among the driest communities in Honduras—it is not uncommon for farmers there to lose up to 80 percent of their crops each year.

Juana knows this well. For years, she and her family suffered drought and famine. Crops died, water evaporated, and the children became thin and weak.

Today, thanks to ADRA, Juana has a cement water reservoir, a drip irrigation system, sustainable crops, business training and agricultural management, and more.

"When I see this plot of land planted, I thank God for the help of ADRA," Juana said. "We have really seen a change in our community. Now we have means to support our families. We are all happy."

Though she will face some of the same daunting circumstances as her young parents, baby Ngan will grow up with access to clean drinking water right out of the faucet. Thanks to a project to provide clean water to rural communities in Vietnam, ADRA is proving that water-borne illnesses are not synonymous with poverty.

"When the water was dirty, we were sick to our stomachs," Lung Thi Chien said. Though there are still concerns within the household, dirty water is no longer one of them. "Clean water is good for my whole family," she added.

Every Child in School

In October 2019, ADRA and the Seventh-day Adventist Church pledged to gather one million signatures in a campaign to see every child, everywhere, in school. This petition aimed to mobilize our global faith community of more than 22 million members to recognize and support the 262 million children worldwide who do not have access to school.

Though the needs and obstacles vary, the result is the same: boys and girls who must work, marry, fight, beg, or starve. ADRA and the Adventist church recognize that education offers hope for a better life and that we must do everything possible to speak up on behalf of out-of-school children.

"Many children and young people, particularly girls, who lacked the opportunity or resources to go to school, are now going to school because their families understand the importance of education for their children," says Emmanuel Amegnito, ADRA associate regional director and regional liaison in the West-Central Africa Division of the Seventh-day Adventist Church, whose region led globally the petition signature count.
